Bitches in season will NOT be allowed to run.

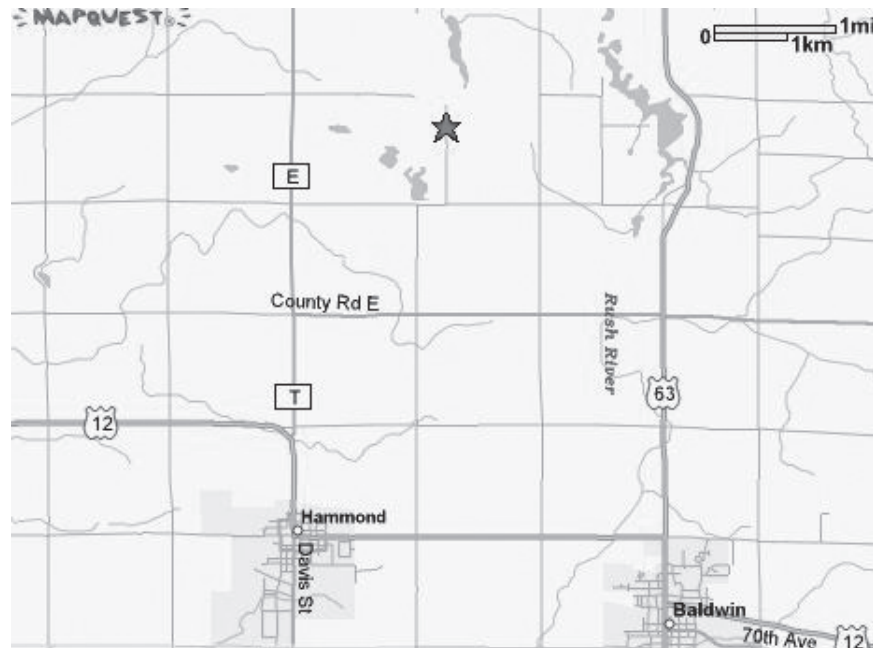

From Wisconsin Interstate I-94, Take exit 16 for County Road T at Hammond Exit, .03 miles. Go North on County Road T, 3.4 miles through the town of Hammond. Stay to the right on County Road T (just past the Hammond Golf Course) 2.1 miles, to 110 th. Avenue, turn Right on 110 th. Avenue go 1.0 miles, turn left to stay on 110 th. Ave., 0.2 miles, Turn Left on 192 nd. St. 0.8 miles. Field Trial will be at the end of the dead end road. Look for signs that will direct you to the appropriate field for the trial.
