The June meeting will be held at Laurie Engel's on **SATURDAY, JUNE 16 AT 7:30 PM.**


Bring a dog and your walking shoes. We will walk around Lake Nokomis.

Simple dog treats you can make yourself.

Recipes

Oven-Dehydrated Liver Treats

- Slice beef liver or chicken livers into thin strips, approximately 1/8 inch thick.
- Lay the slices on a rack. Leave approximately 1/2 inch of space between slices of meat to allow for proper air circulation. Place the rack on a cookie sheet with sides.
- Cook the meat in a preheated 145 degree Fahrenheit oven for eight to 10 hours.
- Remove the liver strips from the oven when they feel leathery, like jerky, without being brittle.
- Leave the strips on the racks and allow them to cool completely. Place the cooled liver strips into storage bags or jars. Leave the storage containers open overnight to temper the dehydrated meat.

Check each slice of dried liver to see that it is still firm and leathery. If any pieces feel soft, you can repeat the dehydrating process or set them aside to feed to your dog right away. Properly dried liver strips should be put back into their storage containers and stored in the refrigerator or freezer for up to two months.

Sweet Potato Treats

- Slice the sweet potatos 1/8 inch thick or so.
- Place the slices on a cake rack which is placed on a cookie pan (this allows air to get under the slices).
- Use as low a temperature as you can for 2+/- hours. Hold the oven door slightly open.
- Your goal is to dry out the slices slowly.

If they look dry and kind of bend like leather - you've got them. They are fibrous, and help keeping teeth clean.

When done right, they taste pretty good!

Easy Liver Cookies

Chop 1 lb. of liver into 1-inch cubes. Place it in a blender with a approximately 1/4 cup of water and puree into a paste.

Transfer the liver puree into a mixing bowl. Add the cornmeal, oats and rice. Stir until the ingredients are well mixed.

Drop the cookie dough onto a greased cookie sheet by the teaspoonful. Use the back of your spoon to lightly flatten the top and shape it into a cookie.

Bake in a preheated, 350 degree Fahrenheit oven for 15 to 20 minutes. Transfer the liver treats to a cooling rack and allow them to cool completely before placing them in a storage container. Store in the refrigerator.

Tips & Warnings

Place fresh livers in the freezer for an hour or two before slicing, long enough for them to firm up without completely freezing. Slightly frozen livers are easier to slice into thin strips than completely thawed meat.

Prevent the liver cookie batter from sticking to your spoon while you are trying to drop or shape cookies by dipping it into a glass of water or sprinkling it lightly with cornmeal.

Properly wash your hands, cutlery and cutting surface with hot, soapy water after handling raw liver. Do not allow raw slices of liver or juices to come in contact with cooked products.

Since you never know when an accident will happen, keeping a pet emergency kit at your home is a good idea. A smaller kit could be used in the car. You can put a first aid kit together yourself and buy the items separately, or buy one readymade. If you make one yourself, use a small plastic tub with a tight fitting lid to store the following items:

- Poison control center phone numbers

Equipment and Supplies

- Muzzle, or roll of gauze for making a muzzle
- Magnifying glass
- Scissors
- Tweezers
- Nail clippers and metal nail file
- Styptic powder or sticks, Kwik Stop, or cornstarch
- Penlight
- Nylon slip leash
- Eye dropper or oral syringe
- Cotton swabs
- Cotton balls
- Clean towels cloth and paper
- Rectal thermometer
- Lubricant such as mineral oil or KY Jelly (without spermicide)
- Disposable gloves
- Syringes of various sizes
- Needle-nose pliers or hemostats
- Grease-cutting dish soap
- Bitter Apple or other product to discourage licking
- Pet carrier
- Towel or blanket to use as a stretcher, another to keep your dog warm during transport (some pharmacies and camping outlets carry a thermal blanket)
- Cold packs and heat packs (wrap in towel before using)
- Stethoscope

Bandaging Materials

- Square gauze of various sizes some sterile
- Non-stick pads
- First aid tape both paper (easily comes off of skin) and adhesive types
- Bandage rolls gauze and Vetwrap
- Band-Aids (for humans)

Nutritional Support

- Rehydrating solution such as Gatorade or Pedialyte
- Nutritional supplement such as Nutri-Cal, Vitacal, or Nutristat
- High sugar source: Karo syrup

Medicines*

- Wound disinfectant such as Betadine or Nolvasan
- Triple antibiotic ointment for skin
- Antibiotic ophthalmic ointment for eyes, e.g., Terramycin
- Eye wash solution
- Sterile saline
- Antidiarrheal medicine such as Pet Pectate
- Diphenhydramine (Benadryl) for allergic reactions (obtain dose from your veterinarian)
- Cortisone spray or cream, such as Itch Stop
- Ear cleaning solution
- Hydrogen peroxide (used to make a dog vomit only use as directed by a veterinarian)
- Activated charcoal to absorb ingested poisons (consult your veterinarian before using)
